Governor's Actions

The Governor implemented the following three steps:

Step 1 (implemented and ongoing)

 Freezing positions and large General Fund (GF) contracts (\$100,000+) resulted in reversions of \$67 million from FY 2019-2020 biennium, higher than the \$30-\$40 million anticipated, at least partially attributable to savings from "Step 1"

Step 2 (implemented as of July 1, 2020 for budgets and ongoing)

• Required agencies to recommend a 10% GF reduction (\$335.1 million; \$254.6 million without state major maintenance reductions and fund swap)

Step 3 (not implemented - pending passage of the Budget Bill for July 1, 2021)

• Asked agencies to identify another 10% GF reduction (\$111 million; \$62.7 million without state major maintenance reductions and funds swap)

Major Governor's Recommendations*

- Total average, recommended reduction (Steps 2 and 3) = 15% (11% without state major maintenance**)
 - No reductions to law enforcement or public safety for Step 3
- Major Maintenance (MM) = 25% reduction (\$32.2 million)
 - Reduced MM multiplier from 2% to 1.5%
 - PLUS, shifted remaining \$96.6 million from GF to SIPA (fund swap)
- One Percent Severance Tax Account (OPSTA)
 - Use the \$128.8 million for GF expenditures <u>or</u> directly support the 5% statutory reserve amount

Major JAC Changes from Gov Rec

- Net Joint Appropriations Committee (JAC) changes by funding source:
 - GF = additional **\$1.5 million** in budget reductions
 - Strategic Investments and Projects Account (SIPA) = net \$21.0 million (including capital construction) in lower recommended appropriations*
 - School Foundation Program account (SFP) = additional \$3.1 million in budget reductions

*Does not include Governor's recommendation of SCCA transfer to SIPA for which there are insufficient funds.

Major JAC Changes from Gov Rec

- One-percent severance tax remains in OPSTA; eliminate OPSTA deposits to Legislative Stabilization Reserve Account (LSRA) and Permanent Wyoming Mineral Trust Fund (PWMTF)
- Remove LSRA backstop for employer health insurance contributions (\$21.33 million)
- Maintain National Guard Youth Challenge Program
- Transfer \$19.6 million from SIPA to balance School Capital Construction Account (SCCA)

Major JAC Changes from Gov Rec

- Reduced SFP funding in various divisions in Department of Education and School Foundation Program by 15%
- Remove SIPA funds from University of Wyoming and community college new capital construction requests (other bill)
- Reduced Gov's local government distributions cut by one-half (\$10.5 million reduction per Governor and \$5.25 million reduction by JAC) (other bill)

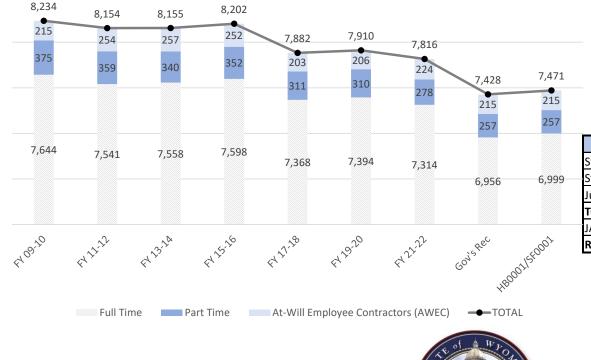

Other Major Appropriation Bills

- SF64, Local government distributions-revisions-2, reduces \$5.25 million LSRA (JAC position); Senate position reduces \$10.5 million
- HB121, State funded capital construction, appropriates:
 - \$16.9 million Federal Funds
 - \$94.0 million Private Revenue (local UW and community college funding)
 - \$ 5.8 million Special Revenue
 - \$31.0 million Strategic Investments & Projects Account
- HB61, School finance recalibration, reduces School Foundation Program
 - \$90.5 million FY 2022 / \$81.2 million FY 2023 / \$81.1 million FY 2024

- GF: \$15.9 million
- SIPA: \$52.1 million
- LSRA: \$1,139.5 million
- OPSTA: \$128.8 million/biennium

Wyoming Legislative Service Office

- Outlook
- GF: Next biennium \$27 million shortfall PLUS statutory reserve amount; Long-term - balanced
- SFP: Approximately \$250 million/year PLUS investment guarantees in future years
- SCCA: Approximately \$50 million/year PLUS investment guarantees
